SIERRA ROADWORK SCHEDULE

Sunday through Saturday
December 4 – December 10, 2011

LONG-TERM PROJECTS

Interstate 80 Donner Safety Roadside Rest Areas (Nevada County) Work continues to replace rest area. When this \$12.5 million project is complete, the facilities and parking will be upgraded to meet the demands of the more than three million annual visitors and will be compliant with the Americans with Disabilities Act standards. The westbound facility reopened on November 22. The eastbound facility is scheduled to reopen **December 20**.

State Highway 49 (Nevada County) Work has begun on the \$29 million Highway 49/La Barr Meadows Project that will widen State Route 49 to four lanes between Little Valley Road and Norambagua Way, just south of Grass Valley. The project includes a signalized intersection at La Barr Meadows Road, widening of shoulders, right-turn pockets and new sound walls. Completion is expected by fall 2012. **Project is in winter suspension.**

Interstate 80 (Placer and Nevada Counties) from Carpenter Flat to Hampshire Rock: Work continues on the \$167 million Emigrant Gap project on Interstate 80. Work includes total roadway replacement with Portland Cement Concrete, improving the drainage systems and installing new sediment/debris collection systems. Completion is expected in the fall of 2013. **Project is in winter suspension.**





Interstate 80 (Nevada County) from Donner Summit to Donner Lake: Work continues on the \$71 million Donner III Project to improve Interstate 80. Work includes repaving the existing roadway with Portland Cement Concrete, reconstructing failed sections of roadway, adding new drainage systems, upgrading existing drainage systems and construction of a new sediment/debris collection system. Completion is expected in early winter 2011. **[THIS PROJECT IS NOW COMPLETE!](#)**

SHORT-TERM PROJECTS

State Route 20 (Nevada County) from the Yuba County line to Interstate 80: Motorists can expect east and westbound #2 lane closures from **8 a.m. to 5 p.m. Monday through Friday**. A Caltrans crew is scheduled to do miscellaneous maintenance work.

State Route 20 (Nevada County) from Bennett Street to Bank Street: Motorists can expect westbound #2 lane and shoulder closures from **8 a.m. to 5 p.m. Monday through Friday**. A contractor is scheduled to construct sidewalks.

State Route 49 (El Dorado and Placer Counties) from State Route 193 to the Nevada County line: Motorists can expect one-way traffic controls in various locations from **7:30 a.m. to 3:30 p.m. Monday through Friday**. A Caltrans crew is scheduled to do miscellaneous maintenance work.

State Route 49 (Nevada County) from the Placer County line to the Yuba County line: Motorists can expect north and southbound #1 lane closures from **8 a.m. to 5 p.m. Monday through Friday**. A Caltrans crew is scheduled to do miscellaneous maintenance work.





State Route 49 (Yuba and Sierra Counties) from Marysville Road to the Yuba Pass Summit: Motorists can expect one-way traffic controls in various locations from **7:30 a.m. to 4 p.m. Monday through Friday**. A Caltrans crew is scheduled to do miscellaneous maintenance work.

Interstate 80 (Nevada County) from Yuba Gap to Donner Lake Undercrossing: Motorists can expect various east and westbound lane closures from **7 a.m. to 5 p.m. Monday through (Friday – Noon eastbound) Friday**. A contractor is scheduled to do guardrail repair work.

Interstate 80 (Nevada County) from State Route 89 south to West Truckee: Motorists can expect various east and westbound lane closures and one-way traffic controls from **7 a.m. to 5 p.m. Monday through (Friday – Noon) Friday**. A contractor is scheduled to do bridge work.

Interstate 80 (Placer County) from Yuba Gap to Kingvale: Motorists can expect various east and westbound lane closures from **7 a.m. to 4 p.m. Monday through (Friday – Noon eastbound) Friday**. A contractor is scheduled for guardrail repair.

Interstate 80 (Placer County) from Kingvale to Separate Align: Motorists can expect various westbound lane and shoulder closures from **5 a.m. to 6 p.m. Monday through Thursday**. A contractor is scheduled to install overhead signs.

Interstate 80 (Placer County) from State Route 193 / Hillview to Gold Run: Motorists can expect intermittent lane closures in various locations from **7:30 a.m. to 3:30 p.m. Monday through Friday**. A Caltrans crew is scheduled to do miscellaneous maintenance work.

State Route 89 (Nevada and Sierra Counties) from Rainbow Road to Webber Lake: Motorists can expect one-way traffic controls at various locations from **8 a.m. to 3:30**





p.m. Monday through Thursday. A Caltrans crew is scheduled to do miscellaneous maintenance work.

State Route 174 (Nevada County) from Bear River Bridge to Auburn Street: Motorists can expect various east and westbound lane closures from **8 a.m. to 5 p.m. Monday through Thursday.** A Caltrans crew is scheduled for miscellaneous maintenance work.

State Route 174 (Placer and Nevada Counties) from Interstate 80 to the Bear River Bridge: Motorists can expect one-way traffic controls from **7:30 a.m. to 3:30 Monday through Friday.** A Caltrans crew is scheduled for miscellaneous maintenance work.

State Route 174 (Placer County) from Main Street to Long Ravine Road: Motorists can expect one-way traffic controls from **8 a.m. to 3 p.m. Monday through Friday.** A contractor is scheduled to do underground utility work.

Lanes are numbered from the center divide (#1) to the shoulder (#2, 3, 4, etc.). Unexpected schedule changes may occur.
